PAYMENT OPTIONS

OPTION 1-Independent Bank (**CHARLOTTE BRANCH ONLY**) accepts payments during bank hours from 12/1/2025 through 3/2/2026. You must present the original tax bill (salmon). The bank will provide you a receipt of payment.

OPTION 3- In Person payment can be made during the following office hours: Monday, January 29th 8am-12pm, Monday, February 16th 8am-12pm, Saturday, February 28 8am-12pm, and Monday, March 2 8am-5pm.

Did You Know...

Townships are a product of Michigan's early history. Historians believe American township government was modeled after the English system of government. Settlers in New England developed small communities that delivered local services, while a county served as the administrative arm of government. When the Erie Canal opened, many New Yorkers migrated to Michigan and brought their form of government with them.

While you might hear local units in Michigan referred to as "cities and towns," that's incorrect. Michigan does not have towns—it has townships, cities, and villages, with townships governing 96 percent of Michigan's land area outside of cities. In fact, in Michigan, if you do not live in a city, you live in a township.

Michigan is one of 20 states that currently have some form of township government. In Michigan, it is often difficult to discern the differences between townships, cities, and villages. (Information provided by MTA)

Clerks' Corner...

Join the TEAM-Become a Poll Worker in Michigan- Election Inspectors i.e. poll workers, are hired, paid, and trained local government workers who assist with running local elections in compliance with Michigan Election Law.

Eligibility requirements to serve as an election inspector in Michigan are as follows:

- You must be at least 16 years of age.
- You must be a registered voter in Michigan if 18+ years of age. Individuals aged 16 – 17 must be a Michigan resident.
- You must not have a felony or election crime conviction.
- You must not be an election challenger, a candidate, a member of a candidate's immediate family, or a member of the local board of canvassers.
- You must affiliate with a political party. Party registration is not a requirement. Michigan law requires that election inspectors disclose political affiliation to ensure balanced staffing. Affiliating as "independent" or "unaffiliated" is not a legal option for an election inspector.



While not a requirement, Michigan election clerks are seeking individuals with the following skills to serve as election inspectors:

- Organization
- Management and supervising
- Customer service
- Project management
- Familiarity with technology, such as operation of computers and software.
